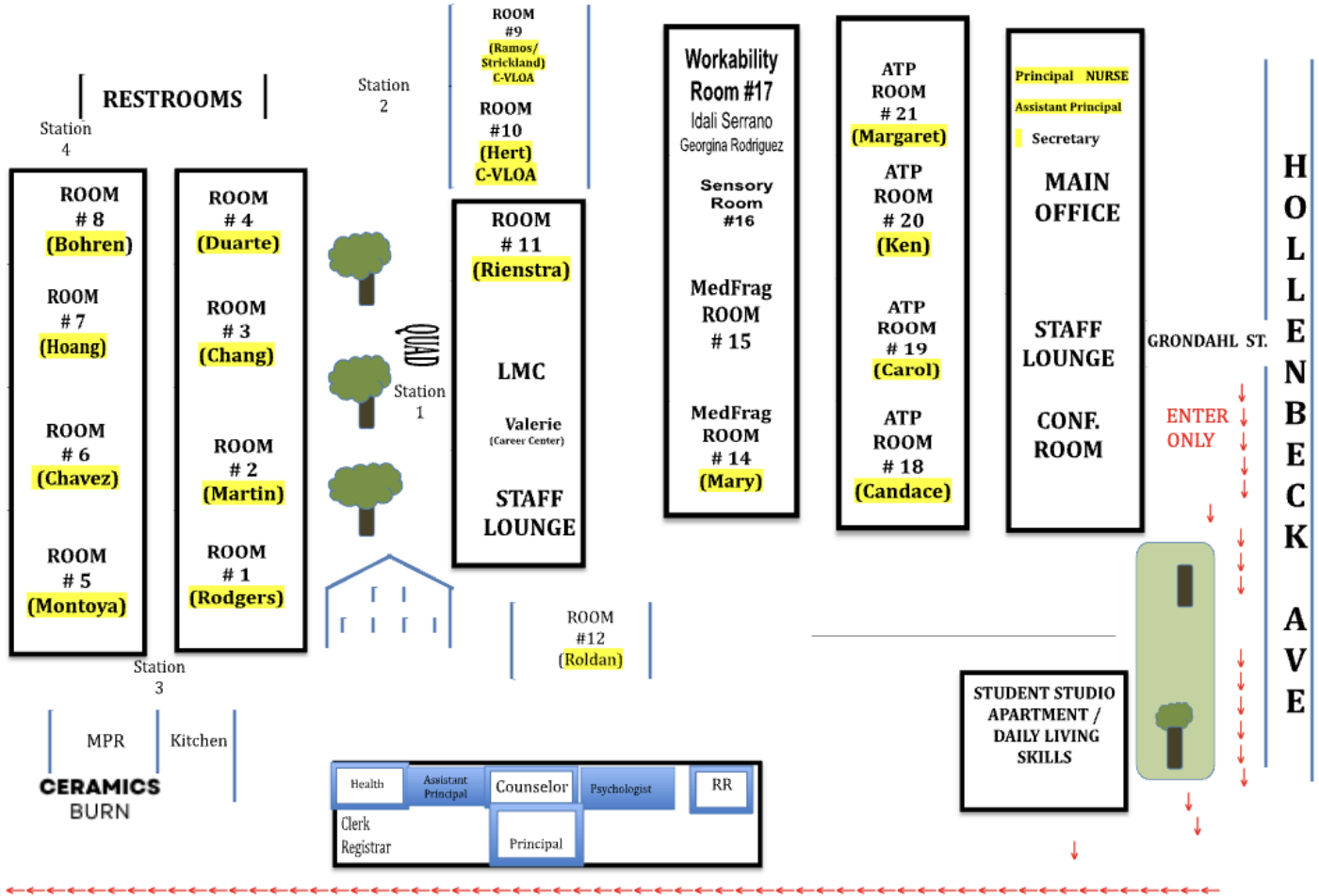

Summer graduates must be within 15 credits before attending summer school or attend Adult Ed, a college high school diploma program, or a charter options program at the end of the spring semester.

## **School Services**

### **Counseling**

The counseling and guidance program is an integral part of the total school educational program and is unique in that it begins before the student arrives at Fairvalley. Enrollment begins with a review of the student's transcript, which shows the number of credits accumulated, courses completed, and required courses needed. From this, an individual learning program and a sound educational plan will be developed.

A Personal Learning Plan (PLP) is the start of the orientation process. This plan is in continuous development and review as the student progresses through the Fairvalley program. The Personal Learning Plan begins with individual assessment in basic areas and continues to include career choices and development. The program is designed to meet the personal, social, and educational/career needs of the students.

Depending upon the student's needs, other options are available; these may include Tri-Community Adult Education and CTE Programs, the Work Experience Educational Program(WEEP), full-time employment (AB1679), Citrus and Mt. San Antonio Colleges' early college credit programs. A Career Center is operated at Fairvalley High School. The center is provided with an aide who is available to both students and faculty. Students are encouraged to refer themselves to the counseling office for additional support services provided.

### **Health Services**

Students who have become ill and are unable to remain in class will receive a pass from the teacher to the office. Students must remain in the office. If you are not well enough to remain in class, your parents will be contacted and asked to take you home. No student may be sent home unless a parent or guardian can be contacted. Report all injuries received at school to your teacher immediately.

### **Work Experience Program**

Work permits are required for any student working at any establishment other than at home for their parents. Application forms are available in the work experience office and must be completed by yourself, your parent / Guardian, and your employer before the work permit is issued. The student, parent, and employer each have certain obligations to perform while the student is working. Students on Work Experience may earn five credits per semester. Students must work a minimum of ten hours per week. The Work Experience coordinator will be able to answer any questions you may have regarding work permits.

### **Attendance Policies and Procedures**

The Covina-Valley Unified School District believes that regular attendance plays an important role in student achievement. Fairvalley High School will work with parents/guardians and students to ensure compliance with all state attendance laws and may use appropriate legal means to correct problems of chronic absenteeism and/or trancies, especially when absences threaten to negatively influence the student's educational success.

Education Code Sections 48200, 48269, 48262, and 48267 set forth requirements that a parent, guardian, or other persons having charge of any child shall send the child to school. These sections strictly prohibit truancy, tardiness, and absences from school without an approved excuse. Students are held accountable for days missed from school. They will be required to make up for the time lost. Poor attendance may result in a referral to SART, SARF, District Attorney, Probation, or the Department of Children's Services.

### **Clearing Absences**

It is the parent/guardian's responsibility to notify the attendance office when a student is absent from school by telephone call or written note **within three days of the absence**. Please contact the attendance office at (626) 974-4811. Upon their return to school, students are to clear their absences with the attendance office before their first-period class. Absences not cleared within three days will be considered unexcused. If your student will be out, please contact the Attendance Office to arrange for a Temporary Independent Study.

## **Excused Absences**

For school purposes, an excused absence is one due to illness, quarantine, or medical, dental, and optometric services rendered. An absence from school to attend the funeral of an immediate family member or relative for one day in the state or three days outside the state is also considered excused.

## **Unexcused Absence**

For school purposes, an unexcused absence is when the student is out of school for reasons other than an excused absence. Students who are excessively absent may be referred to the Fairvalley High School Student Attendance Review Team (SART). Subsequent absences may be referred to the C-VUSD Student Attendance Review Board (SARB).

## **Tardiness**

Students are expected to be on time for class. If detained by a teacher, the student should ask the teacher for a pass. Students who are late to class with a satisfactory excuse will be given an excused tardy by their teachers. Students who are habitually tardy will be subject to disciplinary action. Please see the Fairvalley High School Tardy Policy below:

- **Tardy Policy:**

There are NO EXCUSED TARDIES. If a 15% tardy rate is reached, students will be deemed habitually tardy. Students deemed habitually tardy: 1) Two official notification warning letters in person and mailed. 2) If a student does not correct the problem in a timely manner (4 weeks) and attendance does not improve, the student may lose privileges.

## **School Attendance Review Team**

A School Attendance Review Team (SART) meets at the request of the Student Services Administrator when a student's absences, excused or unexcused, become excessive. Parents and students are required to attend this meeting. SART will develop an attendance and/or behavioral contract for the student and parent. Failure to abide by the contract may result in a referral to the School Attendance Review Board.

## **School Attendance Review Board**

The School Attendance Review Board (SARB) meets with students and parents referred by the District Supervisor of Child Welfare and Attendance. The Board consists of members of local Law Enforcement, the District Attorney's Office, a Probation Officer, the Supervisor of Child Welfare and Attendance, and other community resources. The Board will determine if the responsibility for poor attendance rests with the parent or the child and make the appropriate legal referral.

## **Trimester Program**

Students at Fairvalley are enrolled in a trimester schedule. Students take six classes per day that meet daily for 42 minutes. The regular school day begins at 8:30 a.m. and ends at 1:30 p.m.

The following are some of the benefits of the trimester schedule:

1. Students can accelerate. Students will be enrolled in a maximum of 6 courses every trimester for a maximum of 18 semester courses every school year.
2. Students can retake more courses to get on track to meet high school graduation requirements.
3. Students can explore various electives and/or take additional core classes.

### **Special Education**

The C-VUSD Special Education Department is dedicated to ensuring that all students receive individualized services and support in an inclusive culture to provide a future of limitless possibilities.

If you feel that your child may be eligible for and in need of an IEP, please contact your school site psychologist or site administrator for more information.

### **504 Plans**

Section 504 of the Rehabilitation Act of 1973 is a civil rights law that prohibits discrimination/harassment on the basis of disability in any program or activity receiving federal financial assistance. The District has specific responsibilities related to the provision of a "free appropriate public education" (FAPE) to school-age individuals with disabilities under Section 504 and the Individuals with Disabilities Education Act (IDEA).

To meet the criteria for Section 504 protections, a child must:

- Have a physical or mental impairment that substantially limits one or more major life activities
- Have a record of such impairment
- Be regarded as having such an impairment

If you feel that your child may be eligible for, and in need of, a 504 Plan, please contact your school site psychologist or site administrator for more information.

### **Closed Campus**

#### **Leaving Campus Midday**

Fairvalley High School is a closed campus. Providing a safe and orderly campus environment is important. Therefore, all students are required to stay on campus for their entire school day. However, students are allowed to leave during the school day with parental approval under the following circumstances: Students who have medical or dental appointments and have been checked out by a parent with the Attendance Office.

Students who drive and have parental permission to leave campus during the school day for medical or dental appointments or emergency reasons must submit a note to the Attendance Office at the beginning of the school day to be issued an off-campus pass.

Parents will not be able to excuse these absences at a later time if their student has left campus without a pass.

### **Visitors on Campus**

Fairvalley is a closed campus and does not allow student visitors. If an emergency or unique situation arises where a non-student must be on campus, permission must be sought through the principal's office. All visitors must go through the RAPTOR system. Please bring your photo ID with you.

### **Campus Pass**

A student seeking permission to leave the classroom will be given a campus pass by the instructor.

### **Food Delivery**

Due to safety concerns, Fairvalley High School does not accept food deliveries on campus.

### **Out-of-Bounds Areas**

Students are required to stay within supervised areas during brunch and lunch. Please reference the school map of Out-of-bounds areas. Failure to stay within supervised areas may result in disciplinary action.

## **Behavioral Guidelines and Expectations**

### **Student Parking**

Campus Supervisors make regular checks of all parking facilities; however, Fairvalley is not responsible for damage to or theft of student vehicles. Students are expected to abide by the following rules:

#### **Parking Lot Rules**

1. Students may only park in student lots and spaces. Students may not park in spaces designated for faculty/staff/visitors.
2. The speed limit in the parking lot is **5 MPH**.
3. All vehicles must be parked within the designated parking lines and headed in the proper direction.
4. All traffic must be in the proper direction. Do NOT drive against the flow of traffic.
5. When exiting the parking lot, observe posted signs and markings.
6. Burning out, excessive speed, or horseplay of any kind will be cause for disciplinary action and revocation of the parking pass. Students not following safe and legal driving practices on campus will be subject to disciplinary action.
7. Students are not permitted to loiter in the parking lot at any time, including before or after school, during the school day, at lunch, or between classes.

### **Vehicle Searches**

All vehicles parked in the student lot, on school grounds, or parked adjacent to school grounds for the purpose of arriving at or leaving from school are subject to search by school or police officials when there is a reasonable suspicion of involvement in an unauthorized activity.

## **Bike and Skate Policy**

Students may not ride bikes, skateboards, or skates on campus before, during, or after school. Bikes/skates may not be carried around campus and must be locked in the rack during the school day. Although the school attempts to provide a secure place for them, it is not responsible for the theft or damage of any bike, skate, or skateboard brought on campus. Bikes/skates will be confiscated if the policy is broken. Students with repeat offenses will no longer be allowed to bring these items on campus. Students who use these items at school risk having the item confiscated. The Covina Municipal Code allows the police to issue citations to students who bike/skate on school grounds. Skateboards must be carried while on campus and not ridden to ensure the safety of others.

## **Dress Code**

Covina-Valley Unified School District actively supports the concept of providing a safe, positive atmosphere on campus to allow all students to excel, feel physically and emotionally secure, establish tolerance for everyone, exercise personal responsibility and good judgment, and focus on learning. Student dress has been shown to influence behavior and the learning environment. The standards apply to all students. The only exception is for school-related organizations wearing designated uniforms for a specific purpose. The following policy regarding student attire has been approved by the Board of Education.

1. Students are expected to wear:
  - a. clothing that is hemmed and free from tears, rips, and holes
  - b. clothing that is not revealing (must not show any “private” body parts or undergarments)
  - c. school and personal property (i.e., notebooks, folders, backpacks, etc.) that are free of graffiti/tagging
  - d. clothing and accessories worn in the manner in which they were designed to be worn
2. Students may not wear, display, or have clothing and/or accessories that:
  - a. indicate an association with a group (such as taggers, gang, or crew that is determined to be detrimental to the safety and well-being of the school community)
  - b. are obscene, sexually explicit, suggestive, or derogatory
  - c. express or advocate violence; express racial, gender, ethnic, or religious messages interpreted by school personnel as negative, derogatory, or inappropriate
  - d. promote or advocate the use of drugs, alcohol, tobacco, or intoxicants of any kind
  - e. create a disruption to the safe and orderly operation of the school
3. Hat Policy: Hats and headwear that meet all provisions of the Fairvalley High School Dress Code are allowed with the following exceptions:
  - a. Hats may not be altered/personalized
  - b. Hats must be appropriate to the weather; e.g., snow hats, raised sweatshirt hoods, beanies, and knit caps are allowed only during very cold or inclement weather necessitating winter or raincoats.



- c. Hair nets, hair trainers, do-rags, and similar head covers are not allowed
- d. Teachers and office staff have the option of requiring that hats be removed indoors

School administrators will make reasonable decisions regarding dress standards that reflect the goal of safety and a positive learning environment. Whenever a student's appearance or dress is in violation of the dress code policy, the student will be given the choice of either contacting someone to bring a change of clothing or wearing a loaner piece of clothing for the remainder of the day.

### **Electronic Communication Devices**

Fairvalley High School allows student possession or use of electronic communication devices on a school campus; however, it does not assume liability if such devices are damaged, lost, or stolen. All electronic communication devices are to be completely turned off (including any text messaging functions) inside the classroom during the instructional day unless directed by the teacher and/or administrator, as well as during outdoor classes, assemblies, meetings, and other school-day activities. Electronic communication devices may be used in a class if directed by the instructor as part of the instructional activity. Except as otherwise provided in this policy, any use during all other times is strictly prohibited. If such devices are turned on or used without permission, any teacher or administrator has the right to immediately confiscate the device. Additionally, speakers are not allowed on campus and will be confiscated.

### **Confiscated Items/Lost Property**

Confiscated items such as skateboards, cell phones, and other electronic devices will be released to the student on the first offense. Items will only be released to a parent or legal guardian thereafter. Repeated offenses will result in disciplinary action. The school is not responsible for any clothing items not claimed within a week. Keeping found property is considered theft. Found property should immediately be turned into the Lost and Found in the Fairvalley Front Office.

### **Personal/School Property**

FHS assumes no responsibility for the loss or theft of personal property. Electronic devices such as cell phones, iPads, etc., are all considered personal property and are the sole responsibility of their owners. The administration will investigate the loss of such personal property at its own discretion, and students are strongly encouraged to leave all such items at home.

### **Items for Sale**

Students are not permitted to sell any items on the Fairvalley High School campus or at any school-related activities. These items include, but are not limited to, soda, candy, chips, and homemade snacks etc. Students caught selling will be subject to further disciplinary action.

## **Academic Integrity**

Any student caught cheating will be given a “0” or “F” grade on that particular assignment. Cheating includes but is not limited to copying another student’s test answers, homework, or essay; taking pictures of a test or assignment and sending them to other students; giving answers to a test or homework assignment; and plagiarism, which also includes the internet. Any student caught cheating will be subject to disciplinary consequences.

## **Textbooks, 1-to-1 Devices, and Other School Equipment**

Books and other materials or equipment issued to students for home use remain the property of the school district. Additionally, students will be assigned a classroom textbook to be shared with other students in other sections. All materials and equipment must be kept clean, handled carefully, and returned in good condition. Students will be required to pay for the cost of repair or replacement for damaged or lost items. The cost of replacing a classroom textbook for damage or loss will be shared among the students assigned to that Textbook. Fairvalley High School and the Covina-Valley Unified School District have provided our students with their own take-home student devices. Students will be loaned a Chromebook/laptop for use on school-related projects and assignments.

**Students are not allowed to store books or school materials in their cars for retrieval during the school day and are expected to keep their personal property with them.**

## **Public Displays of Affection**

Public Displays of Affection (PDA) are not acceptable behavior. Students violating the PDA regulation are subject to disciplinary action. This regulation is in effect at all school activities. Students caught in any area of the campus or at a school event engaging in any type of sexual activity and/or lewd/obscene conduct will be subject to further disciplinary consequences, including, but not limited to, suspension.

## **Bully Prevention Policy**

Fairvalley High School believes that all students have the right to a safe and healthy school environment. The District, schools, and the community have an obligation to promote mutual respect, tolerance, and acceptance.

Fairvalley High School will not tolerate behavior that infringes on the safety of any student. A student shall not intimidate or harass another student through words or actions. Such behavior includes direct physical contact, such as hitting or shoving; verbal assaults, such as teasing or name-calling; social isolation or manipulation; and verbal, written, or electronic off-campus expression.

Fairvalley High School expects students and staff to immediately report incidents of bullying to Student Services. Staff are expected to immediately intervene when they become aware of a bullying incident. Each complaint of bullying will be promptly investigated. This policy applies to

pupils on school grounds, while traveling to and from school, or during a school-sponsored activity. This may also include, but is not limited to, inappropriate use of technology while off campus.

Staff will discuss this policy with their students to assure them that they need not endure any form of bullying. Pupils who bully are in violation of this policy and are subject to disciplinary action up to and including expulsion.

- Any student who engages in bullying may be subject to disciplinary action up to and including expulsion.
- Students are expected to immediately report incidents of bullying to staff or administration.
- Students can rely on staff to promptly investigate each complaint of bullying in a thorough and confidential manner.

### **Fighting**

Fighting is never an acceptable means to resolve conflicts. If a problem exists between or among students, they are encouraged to seek help from the Counseling or Student Services office before the situation escalates to the fighting stage. Both are skilled in conflict resolution and are sensitive to complex issues and situations.

If a fight does occur, both participants may be suspended, regardless of who “threw the first punch.”

Please note: A person cannot claim self-defense if he/she engaged in verbal antagonizing or challenging prior to the physical altercation. Neither can someone claim self-defense if an opportunity was available to get away or seek assistance from school personnel. Just because a person is hit first does not mean that a student has the right to retaliate without disciplinary consequences. Students who are not involved will be expected to clear the fight area, allowing staff and security personnel complete access to the altercation. Any person blocking or obstructing access to an altercation will also face disciplinary action.

### **Pranks/Vandalism**

Vandalism results in the destruction or defacement of property, no matter the intent or the degree of damage. Pranks are considered acts of vandalism and will be dealt with as such. Pranks need not be limited solely to property. Participation in pranks/vandalism may jeopardize a senior's participation in activities, including the graduation ceremony itself.

### **Smoking/Tobacco Products Tobacco-Free**

The Covina-Valley Unified School District is committed to providing a tobacco-free environment and promoting smoking-cessation programs for its students. This policy shall be disseminated

throughout the school district and community by the posting of tobacco-free signs and posters, public announcements at school events, and in written communications.

Students are prohibited from smoking or being in possession of tobacco products in any area on campus or adjacent areas and at all school activities, including events held at the District Field or other off-campus sites. Students are subject to citation by the Covina Police Department. Staff and visitors are also prohibited by law from smoking on campus or at any school event. This includes vaping. Remember, no smoking is permitted anywhere on campus at any time. If you smoke and would like to quit, the Assistant Principal can refer you to an anti-tobacco program.

### **Illegal Substances**

The actual or attempted sale of, use of, or possession of tobacco, alcohol in any form, controlled substances (including prescription drugs), illegal drugs, substances designed to resemble illegal drugs, or substances purported to be illegal drugs while under the jurisdiction of the school shall be subject to appropriate disciplinary action. Such action may include, but not be limited to: police notification, suspension, and/or expulsion. Students who engage in these activities off campus and who return to school or school-sponsored activities shall be subject to the same sanctions outlined above. A student driver is responsible for any and all illegal substances within the vehicle, no matter who is using or found to be in possession of such substances. Students may not have drug paraphernalia in their possession on campus or at any school-sponsored activity. Paraphernalia includes, but is not limited to: lighters, matches, bongos, roach clips, pipes, syringes, razor blades, and rolling papers. This also includes e-cigarettes and/or vaporizers.

### **Canine Detection Program**

The Covina-Valley Unified School District has partnered with a canine detection agency to bring trained detection dogs to all of our District schools. The canines serve to detect and deter illegal substances through random, unannounced inspections. The non-aggressive, retrieving breeds are trained to detect the presence of drugs, alcohol, and gunpowder-based items. If detected and found, the school administration will initiate the appropriate disciplinary action.

### **Medications**

Students must check in all medications at the Health Office. Under no circumstances may any type of medication be ingested outside of the Health Office. Any exceptions must be cleared three days in advance. If the exceptions are medically related, a doctor's note will be needed at the time of the request.

## **Policies, Procedures, and Discipline**

It is the goal of Fairvalley High School to provide students with a campus that is relaxed, safe, and secure. In order to accomplish our goal, we need an environment in which teachers can instruct and students can learn with dignity and with safety. Consequently, we need rules and regulations

that do not limit the educational process but enhance it. With the above purpose in mind, we believe the following rules and regulations are necessary.

### **Rules and Regulations (District Guidelines)**

Students are expected to follow all school and classroom rules. It is expected that all students will enter class prepared to learn. Individual students will not be allowed to monopolize or disrupt class time. Teachers will enforce procedures dependent upon individual rule infractions to ensure effective student guidance and discipline.

#### **Ed. Code Section 48915 states:**

The principal shall recommend a pupil's expulsion for any of the following acts unless the principal finds, and so reports in writing to the Board of Education, that expulsion is inappropriate, due to a particular circumstance, which shall be set out in the report of the incident:

1. Causing serious physical injury except in self-defense
2. Possession of any firearm, knife, explosive, or other dangerous objects
3. Unlawful sale or use of any controlled substance
4. Robbery or extortion
5. Assault or Battery

#### **Ed. Code Section 48900 states:**

Students will be warned/counseled, suspended for one to five days, suspended for the remainder of the school semester, or recommended for expulsion for violating the following acts:

1. Caused, attempted to cause, or threatened to cause physical injury to another person.
2. Possessed, sold, or otherwise furnished any firearm, knife, explosive, or any other dangerous object.
3. Unlawfully possessed, used, sold, or otherwise furnished, or been under the influence of any controlled substance, alcoholic beverage, or an intoxicant of any kind.
4. Committed or attempted to commit robbery or extortion.
5. Caused or attempted to cause damage to school or private property.
6. Stole or attempt to steal school or private property.
7. Possessed or used tobacco of any kind.
8. Committed an obscene act or engaged in habitual profanity or vulgarity.
9. Unlawful possession of, offering, arranging, or negotiating to sell any drug paraphernalia.
10. Disrupted school activities or otherwise willfully defied the valid authority of supervisors, teachers, administrators, school officials, or other school personnel engaged in the performance of their duties.
11. Knowingly received stolen school property or private property.
12. Possession of an imitation (replica) of a firearm.

**Ed. Code Sections 48900.2, 48900.3, 48900.4, and 48900.7 state:**

The following behaviors are not allowed and may lead to suspension or expulsion:

Sexual harassment, Hate violence or hate-motivated behavior, Intimidation, threats, or harassment toward other students, groups of students, or school staff. Terrorist threats were made against school officials, school property, or both. These rules apply when the behavior happens: On school grounds, while going to or coming from school, during lunch (whether on or off campus), or while traveling to or from any school-sponsored activity.

Our school is dedicated to creating a safe, inclusive, and respectful environment for all students and staff. Any violations of these rules will be taken seriously and addressed according to California law and district policy.

**Fairvalley Conduct and Behavior**

Violation of the following rules will result in a warning/counseling, suspension from one class period, or one to five days, suspension for the remainder of the semester, involuntary transfer from the Fairvalley campus, or possible recommendation for expulsion:

1. To cause or attempt to cause injury to another.
2. Possession, furnishing, or distribution of drugs, alcohol, or drug paraphernalia.
3. Possession, furnishing, or distribution of firearms, knives, explosives, or any kind of An item that can be deemed a dangerous weapon on campus.
4. Use of a tobacco product on campus.
5. No directed profanity on campus, in classrooms, towards students, teachers, or school personnel.
6. Fairvalley is a closed campus. Any person(s) entering or leaving campus must have permission from the office staff.
7. Students who are habitually truant will be referred to the following process:
  - a. School Attendance Review Team (S.A.R.T.) – students are placed on a contract.
  - b. School Attendance Review Board (S.A.R.B.) students are referred to the District Attorney.
- 8.) Gang-related activities, including graffiti: Felt-tip pens, magic markers, spray tips, or spray cans are prohibited on campus.
- 10.) Operating a vehicle on campus: Privileges will be revoked for the following violations:
  - a. Speeding and reckless driving.
  - b. Driving other students without the permission of the principal.
  - c. Students are not permitted to take other students off campus during school hours.

**Bus Conduct and Behavior**



Appropriate behavior is expected from all students who are entering, traveling on, or exiting the school bus. California Administrative Code 14103 states that disorderly conduct on the bus or refusal to submit to the authority of the driver shall be sufficient reason for the pupil to be denied the privilege of bus transportation.

The following actions are prohibited:

1. Disorderly conduct
2. Profanity, obscenity, or vulgarity
3. Smoking or possession of tobacco, drugs, or drug paraphernalia
4. Loud or unnecessary noise
5. Standing or kneeling in the seats
6. Standing, sitting, or walking in the aisle while the bus is in motion
7. Placing body part(s) outside the bus
8. Possession of sharp pointed objects of any kind or marking and writing on the bus
9. Objects thrown out of the bus windows

Covina-Valley Unified School District actively supports the concept of providing a safe, positive atmosphere on campuses in order to allow all students to excel, feel physically and emotionally secure, establish tolerance for everyone, exercise personal responsibility and good judgment, and focus on learning. Student dress has been shown to influence behavior and the learning environment. The following policy regarding student attire has been approved by the Board of Education.

Student dress or appearance that, in the judgment of school administration is unsafe, lewd, indecent, obscene, vulgar, promotes the use of drugs or alcohol; indicates affiliation with gangs or negative groups; or disrupts the orderly operation of the school shall result in disciplinary action as well as liability for restitution if damages occur.

### **Safe Place to Learn Act**

#### **EC234 and 234.1**

C-VUSD is committed to maintaining a learning environment that is free from discrimination, harassment, violence, intimidation, and bullying based on actual or perceived characteristics such as disability, gender, gender identity, gender expression, nationality, race or ethnicity, religion, sexual orientation, or association with a person or group with one or more of these actual or perceived characteristics. All school personnel who witness an act of discrimination, harassment, violence, intimidation, or bullying must take immediate steps to intervene when it is safe to do so. Any student who engages in acts of discrimination, harassment, violence, intimidation, or bullying related to school activity or school attendance occurring within a school of the school district may be subject to disciplinary action up to and including expulsion. To report an incident and/or to receive a copy of the district's antidiscrimination, anti-harassment, anti-intimidation, and anti-bullying policies, please contact the school principal.

## **Transfer Policies**

### **Voluntary Transfer**

A student who has voluntarily transferred to Fairvalley High School shall have the right to return to their comprehensive high school at the beginning of the school year or new semester with the consent of the principal or his/her designee.

### **Involuntary Transfer**

Involuntarily transferred students may request a review for the return to their comprehensive high school of residence at the end of each semester.

### **Criteria to Return to a Comprehensive High School**

The District Placement Committee, which is composed of the Fairvalley Principal and Counselor, Supervisor of Child Welfare and Attendance, and Deans or Assistant Principals from the Comprehensive High Schools, will determine whether the transferred student meets the following criteria:

- a. Student and parent or guardian have requested the return to school of residence. All students requesting to return to their school of residence must fill out the form "Application to Return to Comprehensive High School".
- b. Student's academic performance and attendance must be satisfactory.
- c. Students demonstrate a positive attitude and are prepared to make the proper adjustments at the resident high school.

### **Due Process**

This handbook has explained the major disciplinary problem areas and the actions that follow the school rules and regulations. All students are entitled to due process. Procedures are in place that school officials must follow, prior to taking appropriate disciplinary action, as well as procedures that students must adhere to. Students are protected under due process. If a parent/guardian or student becomes involved in a situation in which a suspension or expulsion might result, the process will be fully explained to the parties involved.
