

2025-2026 Enrollment Information

Covina-Valley Unified Schools would like to welcome our new students for the 2025-26 school year. Registration for the 2025-26 school year begins on Monday, February 3, 2025, for all our schools. Please contact your local school for details or visit our website at www.c-vusd.org.

Children entering kindergarten must have been born on or before September 1, 2020. An optional, Transitional Kindergarten class is available free of charge for students who turn 4 years old by September 1, 2025. High-quality, low-cost, and/or free childcare is available for our students. New students entering the district will register online using the online registration portal found on the C-VUSD website, www.c-vusd.org, starting Monday, February 3, 2025. To register online, parents will need an email address. If you need technical support, please call C-VUSD Technology Support Services at (626) 974-7100 ext. 800040.

Once you have completed the online registration, please call the school to finalize your student's enrollment. **Please be aware that you will need to upload a copy of the following during the enrollment process:**

- Your Child's Birth Certificate; Baptismal Certificate; Passport; Statement by the County Registrar or Recorder; or Affidavit from the parent/guardian.
- Proof of your address (utility bill, statement or payment receipts; pay stub; rental/lease property contract or payment receipts; property tax payment receipts; voter registration; correspondence from a government agency; or declaration of residency executed by the parent or legal guardian of a pupil)
- Your Child's Immunization Records including:

Polio Immunizations:

Dates for 3 immunizations. 4th dose is needed if 3rd dose was before the fourth birthday.

DTP (Diphtheria, Tetanus, and Pertussis-Whooping Cough):

Dates for 4 immunizations. 5th dose is needed if the 4th dose was before the fourth birthday. 3 doses ok if one was given on or after 7th birthday. For 7th-12th graders, at least 1 dose of pertussis-containing vaccine is required on or after 7th.

MMR (Measles, Mumps, Rubella):
or

Dates of 2 immunizations (both after the first birthday)

- **Measles Immunization:**

Dates of 2 immunizations (both after the first birthday)

- **Rubella Immunization:** Date of 1 immunization (after the first birthday)
- **Mumps Immunization:** Dates of 2 immunizations (both on or after the first birthday)

Hepatitis B: Dates for 3 immunizations

Varicella Vaccine: Dates of 2 immunizations (A medical exemption through [CAIR-ME](#) is required if the child had the disease)

If you do not have your child's immunization record, you can obtain one from your child's doctor or local health department. You can also access your child's Digital Vaccine Record from myvaccinerecord.cdph.ca.gov.

New students to C-VUSD in grades 6-12 will need to **email** the school the following additional information:

- Most current grades and transcript
- Attendance records
- Discipline records

***Students in Special Education (active IEP) will begin their registration at the Covina-Valley Unified School District office, Special Education Department. Please email Elsa Morales emorales@c-vusd.org a copy of your child's most recent IEP.**

Inter-district transfers (residing outside of C-VUSD boundaries) must have a signed release from your district of residence and must be submitted along with a permit application to Student Services at the District office via email to Kelsey Cerano kcerano@c-vusd.org. Additional documents may be required to process your Inter-district application.
