## Standard PPE for all Schools, Offices, and Buildings

Standard Personal Protective Equipment (PPE) for all schools, offices, and buildings, in accordance with the Los Angeles County Department of Public Health (LACDPH), in Covina-Valley Unified, are as follows:

#### **Facilities and Sites**

- No-touch thermometers
- Extra medical-grade masks
- Proper signage for distancing, handwashing, entry, exits, directions
- Hand sanitizer (stations) in all common areas, classrooms, and offices
- A/C filters cleaned and changed for the highest level of efficiency possible
- Air purifiers in all classrooms (preschool through high school)
- Bottle filler stations
- Sinks with running water, soap, paper towels, hand dryers, and/or hand sanitizer
- Doors and windows should remain closed to allow for air purifiers to work efficiently
- Classrooms linked to an automatic energy management system must keep their doors closed, or damage to the site-wide system may occur
- Whenever feasible, doors should remain closed to ensure fire life safety and lockdown protocol

## All Employees

- 2 cloth masks and 2 facial shields will be provided to all employees
- Masks must be worn while on-site (gaiters, bandanas, pulling up your shirt, etc. are not acceptable)
- Required to use hand sanitizer and/or wash with soap and water (if sinks in classrooms) regularly and prior to using shared tools
- Utilize plexiglass barriers on all student and employee desks

## **Special Staff (additional PPE)**

- Special Education Service Providers, Self-contained Special Education Teachers, Med Frag, LEAP, Autism, Preschool, Nurses, LVNs, health care professionals
  - Upon request, tight-fitting N95 mask and/or medical-grade masks may be worn

## Standard PPE for all Schools, Offices, and Buildings

- Face shields with drape tucked in may be worn when providing individual services (SLPs)
- Gowns will be provided upon request
- Non-latex disposable gloves will be provided upon request
- A thermometer will be provided upon request

### **Medical Exceptions for Staff**

• Staff will be allowed to wear face shields with a drape tucked in, with medical documentation

#### **All Students**

- Required to wear face masks in accordance with LACDPH health order
- Face masks must be clean/washed daily
- Sites shall provide 2 cloth masks
- Students with an IEP or 504 may ONLY wear face shields with a drape when receiving specialized services
- Students may not wear a face shield with a drape in a classroom setting
- Students who are unable to wear appropriate facial covers may only receive instructional services on a one-on-one basis with a support provider

## All Visitors, Vendors, and Contractors

• Required to wear face masks in accordance with LACDPH health order
