In preparing bids, the bidder shall take into consideration the following items. Information shown herein supersedes requirements issued under previous date.

ITEM NO. 1:

CHANGE IN BID FORM:

The plans and scope of work indicate alternates as follows:

Alternate No. 1: Sewage pump; Include in the cost a ten (10) year labor and materials warranty replacement of sewage ejector system pump, and regular preventive schedule of the system. The information on this item is listed in the scope of work, Number 5, Item F and Plans pages C3, C3.1 and C3.2.

Alternate No. 2: Casework Allowance of \$20,000. A signature is required on this alternate. The information on this item is listed in the scope of work, number 5 letter M.

I have enclosed a revised bid form attached to this addendum. **Please use the enclosed bid form when submitting your bid.**

ITEM NO. 2:

REQUESTS FOR CLARIFICATION:

Question: What is the completion time for the project?

Clarification: The completion time for the project is sixty (60) days.

Question: Is the warranty to include sewage ejector pumps and the maintenance schedule? We are unaware of manufacturers that furnish a warranty this long. Please provide the name of a manufacturer that honors ten year warranties.

Clarification: Yes. The manufacturer is Weil Aquatronics, Inc. Weil Aquatronics, Inc. has indicated that they would provide a ten (10) year warranty. Provide pricing on the enclosed revised bid form Alternate No. 1.

Question: From the scope of work item #1: "Contractor to allot...up to (5) pieces of full sized vinyl covered tackboard to replace any damaged existing tackboard wall finish or as directed including 4" vinyl covered joint/gap cover at mod-line. Both aforementioned items to match existing. Please provide specs on existing tackboard and vinyl joint/gap cover.

Clarification: (E) Vinyl covered tackboard and vinyl covered joint/gap cover thickness and color/texture can be matched by bringing samples from your vendor to the site and match. We do not have the specs., exist. tackboard comes with the building that are standard/common.

Question: From the Project Scope of Work item 5-F: "include in the cost a ten (10) year labor and materials warranty replacement of sewage ejector system pump, and a regular preventative maintenance schedule of the system". Are we to only provide the regular preventative maintenance schedule, or also include in the cost the labor to perform the regular preventative maintenance schedule?

Clarification: Cost of labor and materials to perform the regular preventive maintenance schedule should be included.

Question: From the Scope of Work item 5-J: "Paint all exposed 4 x 4 wood posts, two (2) coats each minimum of both primer and finish paints". Please confirm that these posts are to have a total of four (4) coats minimum?

Clarification: Yes, total of 4 coats minimum.

5. <u>TIME FOR COMPLETION</u>: The District may give a notice to proceed within ninety (90) days of the award of the bid by the District. Once the Contractor has received the notice to proceed, the Contractor shall complete the work in the time specified in the Agreement. By submitting this bid, Contractor has thoroughly studied this Project and agrees that the Contract Time for this Project is adequate for the timely and proper completion of the Project. Further, Contractor has included in the analysis of the time required for this Project, Rain Days, Governmental Delays, and the requisite time to complete Punch List.

In the event that the District desires to postpone giving the notice to proceed beyond this ninety (90) day period, it is expressly understood that with reasonable notice to the Contractor, giving the notice to proceed may be postponed by the District. It is further expressly understood by the Contractor, that the Contractor shall not be entitled to any claim of additional compensation as a result of the postponement of giving the notice to proceed.

If the Contractor believes that a postponement will cause a hardship to it, the Contractor may terminate the contract with written notice to the District within ten (10) days after receipt by the Contractor of the District's notice of postponement. Should the Contractor terminate the Contract as a result of a notice of postponement, the District shall have the authority to award the Contract to the next lowest responsible bidder, if applicable.

It is understood that the District reserves the right to reject any or all bids and/or waive any irregularities or informalities in this bid or in the bid process. The Contractor understands that it may not withdraw this bid for a period of ninety (90) days after the date set for the opening of bids.

- 15. The bidder declares that he/she has carefully examined the location of the proposed Project, that he/she has examined the Contract Documents, including the Plans, General Conditions, Supplemental Conditions, Addenda, and Specifications, all others documents and requirements that are attached to and/or contained in the Project Manual, all other documents issued to bidders and read the accompanying instructions to bidders, and hereby proposes and agrees, if this proposal is accepted, to furnish all materials and do all work required to complete the said work in accordance with the Contract Documents, in the time and manner therein prescribed for the unit cost and lump sum amounts set forth in this Bid Form.
- 16. <u>DEBARMENT</u>. In addition to seeking remedies for False Claims under Government Code section 12650 et seq. and Penal Code section 72, the District may debar a Contractor pursuant to Article 15 of the General Conditions if the Board, or the Board may designate a hearing officer who, in his or her discretion, finds the Contractor has done any of the following:
 - a. Intentionally or with reckless disregard, violated any term of a contract with the District;
- b. Committed an act or omission which reflects on the Contractor's quality, fitness or capacity to perform work for the District;
- c. Committed an act or offense which indicates a lack of business integrity or business honesty; or

- d. Made or submitted a false claim against the District or any other public entity. (See Government Code section 12650, et seq., and Penal Code section 72)
- 17. <u>DESIGNATION OF SUBCONTRACTORS</u>. In compliance with the Subletting and Subcontracting Fair Practices Act (California Public Contract Code section 4100 et seq.) and any amendments thereof, each bidder shall list subcontractors on the District's form Subcontractor list.
