Prevailing wage is required for projects over \$1,000. Maintaining certified payroll records is required. The threshold for electronic submittal of certified payroll records to DIR is \$15,000 for Maintenance Projects and \$25,000 for new construction.

### SUBSTITUTION REQUESTS

Substitution requests must be turned in with the bid on the form provided in the bid documents. Contractor must be willing to move forward with materials specified in the bid documents if the substitution request is denied.
