In preparing bids, the bidder shall take into consideration the following items. Information shown herein supersedes requirements issued under previous date.

#### ASBESTOS AND LEAD CLARIFICATION

The following material were found positive at South Hills HS:

### ASBESTOS INFORMATION

500 Building (A4):

\*Roof penetration mastic (40 SF): The roof penetration mastic located at seams, patches, penetrations, pipes, vents, and flashing tested positive for asbestos content.

100 Building:

\*Roof penetration mastic (70 SF): The roof penetration mastic located at North and East Mechanical rooms seams, patches, penetrations, pipes, vents, and flashing tested positive for asbestos content.

400 Building (A4):

\*Roof penetration mastic (50 SF): The roof penetration mastic located at seams, patches, penetrations, pipes, vents, and flashing tested positive for asbestos content.

Normally, asbestos-containing material found to be in good condition is not considered a hazard, unless it is disturbed. Prior to the start of any activity, such as remodeling, demolition, or renovation, that might disturb this material, a Certified Asbestos Consultant should be contracted to design and monitor the project. A California licensed asbestos contractor should be hired to complete the asbestos abatement procedures.

No regulated lead-based paint was identified on the exterior surfaces and/or components anticipated to be impacted by the roofing replacement project in the North and East Mechanical Rooms.
